Hyacinth Edwards-Weekes was born in Antigua and grew up in Montserrat in the British West Indies. Ms. Edwards immigrated to the United States of America in 1983, lived in Texas, Oklahoma, and now resides in Georgia. Currently, she is a Senior Credit Risk Specialist for the Federal Home Loan Bank of Atlanta. Ms. Edwards manages a portfolio of such financial institutions (from de novo to more than \$50 billion in total assets) located in the Bank's footprint (Maryland, North and South Carolina, Virginia, Florida, and Georgia.) She has been reviewing financial institutions since 2000 and is currently an insurance company subject matter expert in the Credit Services Department at the Federal Home Loan Bank of Atlanta. Previously, she worked for SunTrust, GMAC Commercial Finance, and Bank of America. She matriculated at the University of Texas at San Antonio where she obtained a B.B.A in Finance. Ms. Edwards is a patron of the arts and enjoys the ballet, museums, plays, the symphony, and concerts. She is also an active volunteer spent several years teaching adults to read. Ms. Edwards is the liaison between Open Hand, youthSpark, and True Colors, and Synchronicity and the Federal Home Loan Bank of Atlanta; she coordinates volunteer activities and/or funding for these organizations. She is also a member of her employer's Community Involvement Committee. She represents the Community Involvement Committee at events hosted by several partners of the Bank (such as, Georgia Center for Child Advocacy, National Black Arts, YWCA, ToolBank), Ms. Edwards is currently Co-Chair of the youthSpark Board of Directors and is a member of the Midtown Atlanta Rotary Club (MARC), where she has been Co-Chair of MARC's Service Projects Committee for the past two years.



Maya Lawrence Multi-discplinary Artist + Anti-Bias Facillitator

Maya Lawrence is a NYC born-Atlanta based artist, author, and activist, specializing in theater and poetry. As a Resident Artist and The Allyship Program Director at the Tony Award winning Alliance Theatre she uses her superpowers of creativity, curiosity, and compassion to create and facilitate Anti-Bias Allyship experiences for youth, corporations, and organizations in pursuit of becoming the most authentic, empathetic versions of themselves. Her book, and response to the national Racial Reckoning of 2020, "Do You Love the Dark?" was launched as the 2021 Mayor's Summer Reading Club book selection and distributed to thousands of Atlanta's youngest readers. She serves as a board member for Working Title Playwrights, and a founding member of IDEA ATL (Inclusion, Diversity, and Equity in the Arts ATL). As a proud Spelman College alumna, Maya is on a mission to liberate the world through art using love to light the path.



Ofelia de La Valette Owner Dance 101

Though a passion for dance has been with her since childhood, at the age of 34, Ofelia de La Valette found her second calling through dance. For 10 years, she combined her corporate career and intensive training in jazz, hip hop, ballet and modern dance. She was asked to teach an adult beginner jazz class at Emory University. Having learned to dance so late in life, Ofelia developed a unique method of teaching dance to adults in accordance with how adults process and apply information. Her teaching method was so successful that after two years at Emory, she took a huge leap. Ofelia dropped her insurance career and opened the original Dance 101 location. The first studio of its kind that specialized in adult beginner dancers, Dance 101 has grown from its original 35 students to more than 17,000 registered students, with more than 1,200 students coming to the studio each week to take 100+ classes taught by 40 instructors.

Her efforts have been featured in several local as well as national publications, webisodes, podcasts and recently in CNN Small Success Stories, Passion to Portfolio, Making It In America (both CNN domestic and International) as well as Headline News. In July 2011, Ofelia was invited by the White House to deliver the afternoon keynote speech at the Atlanta Urban Entrepreneurship Forum and was presented with The Phoenix Award by Mayor Kasim Reed. She was featured in the "Top 10" in Atlanta's Best Self magazine's Over 40 and Fabulous Atlantans and was one of 50 women profiled in Marlo Thomas's book, It Ain't Over...Till It's Over.
